Brush Up Rice County! is a reimbursement program for homeowners within Rice County looking to paint their houses. If you are eligible, the Rice County Affordable Housing Program will reimburse you up to \$500 for paint to paint your home. It's a simple process: 1) Fill out the application. 2) Upon approval purchase your paint. 3) Paint your house. 4) When the project is complete, submit your receipts to the City. 5) The City will verify your project and you will receive a reimbursement for your paint costs (up to\$500).
